GENERAL CONTRACTORS

[Send us a list of your top five projects.](#) Nominate your sub-contractors who you feel did an exceptional job with superior performance on these projects. Evaluate the projects based on quality of work and/or the ability to work through extremely difficult situations.

SUBCONTRACTORS AND SUPPLIERS

Nominate the project and the individual that you feel did an exceptional job with superior performance. Evaluate the project based on quality of work and/or the ability to work through extremely difficult situations. Your nominations will compete with those submitted by the general contractors.

ALL NOMINATIONS

- (1) Fill out the FILLABLE NOMINATION FORM for each project you are nominating. (One sheet for each project.)
- (2) Provide three or four pictures of the project which show the construction stages in your area of work. These pictures can be either prints or in digital form - please make sure they are not copyrighted; as we will be posting them on social media.



THE COMMITTEE WILL DO THE REST IN PUTTING TOGETHER INFORMATION ON THE PROJECT AND A POWER POINT PRESENTATION FOR AN EXCITING EVENING OF RECOGNIZING CRAFTSMEN IN OUR INDUSTRY.

BASE YOUR NOMINATIONS ON THE FOLLOWING CRITERIA:

1. Nominations are limited to employees of firms who hold SCE membership. (For a list of current members - <https://sceonline.org/members/>)
2. Nominations are not limited to projects in Salem.
3. Nominations are not limited to Salem Architects.
4. Nominations for awards are for Craftsmanship only - not design.
5. Nominations are based on NEW CSI Divisions (0-48)
6. Awards will be presented to the individual who contributed to the success of the project.
7. Any project completed between January 2025 and December 2025 or is currently under construction in this time frame is eligible to be nominated.
8. Each company may only be nominated once per project. For example, if your project is under construction and you nominate your plumbing sub, he may not be nominated when the project is completed.

We will have a category again this year for LIFETIME ACHIEVEMENT AWARD. Contact us if you have a nomination.
